**Unfinished Business:**

**New Business**

Moved, seconded, and approved to incorporate a \$10/day meal fee into clinic and event registrations.

Club moved, seconded, and approved to include in the clinic rules the following:

- Clean up after your dogs, and
- Please talk on phones and hold side-bar conversations away from the clinic so that other participants are not disturbed. Be sensitive to others so they can hear the clinician.

The Club has had requests for an electronic payment option for registrations. This will not include payments for play days. Dave will do the research about options for electronic registration and payment. He will also check into “reg-fox” to allow clinic participants to register electronically.

### **Knox Clinic (January 18-20):**

- The Outlaw Arena has agreed to keep our Knox clinic fee the same as last year at \$275/day. This includes the use of the kitchen (\$25/day).
- Last year, Jack charged \$3,400 last year for the three-day clinic and we paid Outlaw Arena \$800, plus a \$25 deposit before the clinic.
- We paid a stock fee for the three days of \$575.
- We will limit the clinic to 16 dogs.
- We will add \$30 to registrations to cover the meals.
- Auditor fees will also increase to cover the meals.
- Registration will be \$330, plus dues for the first dog. Dues must be paid the beginning of the year.
- The registration will be revised to include an indication of the dog’s level (novice/open)

### **Play Days:**

Outlaw Arena has significantly increase their fees for play days. The charge is \$200/day and \$25 for kitchen. The winter venue has been tabled to look for some options.

Anita has offered their facility if the weather is good. We will need to arrange for a porta potty if we use the Pratt arena. Venue fee = \$10/person, Stock fee = \$10/dog

Ronda Skinner’s place is available for play days at \$10/person, minimum of \$50. Stock fees will remain the same at \$10/dog. Waiting for Club feedback on this option.

### **Elections:**

Current directors are: Kris (came on 2018), Val (came on 2019), and Anita (came on at 2017 and her position is open in 2020)

There was a motion that was seconded that the Treasurer (Lonna Jean), the Secretary (Staci), and the vacating director (Anita) remain the same. Other nominations will be accepted from the floor at the December meeting. Elections will take place at the December meeting.
